

STATEMENT TO REMOVE A HORSE DUE TO SALE/TRANSFER

Mr./Ms. _____ with ID (Passport or Driver's License) number _____ acting as the Owner/Representative of the Stud Farm _____ with PRE Stud Book Code _____, and being aware of the content of the European Union Implementing Regulation 2015/262 by the Commission, dated the 17th of February of 2015, which mandates that the buyer of a horse must execute the Change of Ownership within thirty (30) days after the purchase, **DECLARES:**

Before the Purebred Spanish Horse Stud Book (hereinafter LG PRE ANCCE) that the horse/s listed below are no longer owned by the aforementioned stud farm and that said horse/s have been acquired by the person or persons indicated below, and who must request the Change of Ownership before the PRE Stud Book, so that the removal of said horse/s may come into effect:
